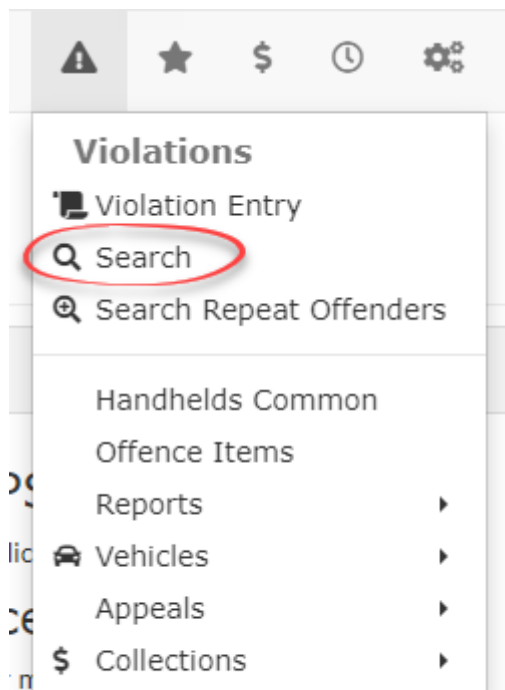


# Cancelling a Violation

## How to cancel a violation
